


Figure 1. Peak Pulse Power Rating Curve




Figure 2. Pulse Power or Current vs. Initial Junction Temperature




Figure 3. Pulse Waveform




Figure 4. Typical Junction Capacitance Uni-Directional




Figure 5. Typical Junction Capacitance




Figure 6. Maximum Non-Repetitive Forward Surge Current Uni-Directional Only




Figure 7. Typical Characteristics Clamping Voltage





Figure 8. Power Derating Curve
